FEBRUARY 13, 2007

REPORT FROM COUNTY HIGHWAY ENGINEER

Tim Zahrn, Highway Engineer, reported on the status of the roads in the community. He stated that there is 253 miles in the County that the Highway Department is responsible for taking care of and there have been crews out since 3:00 a.m. this morning working on clearing these roads. There are 19 routes with 40 guys who cover these and they work very hard for the residents of this County.

The crews were working until 6:00 p.m. tonight and were given a break to rest and will be back out at 4:00 a.m. in the morning. With this particular storm there was a little over 10 inches of snow according to the National Weather Service and they are looking at the possibility of another 4 inches tonight. There is a lot of drifting snow because of the wind. They are using the big motor graters with the big plows along with the other snow plows to break through the snow. He stated that they are trying to make the roads as safe as possible and encouraged people to stay home if they can. At the beginning of the season they had 6,400 tons of salt and sand and have used about 2/3 of it as of today. This event has just been a pushing event so far, but once the roads are cleared off they will be able to apply the salt and sand mixture. Mr. Zahrn expressed appreciation for all of their support.

Mr. Montalbano stated that the Road and Bridge Committee conducted a chili cook off at the Highway Garage to give everyone a chance to see who everyone was and to show their appreciation and it was very successful.

Chairman VanMeter asked Mr. Zahrn if they are at all responsible for the condition of the city, township, or private rural roads. Mr. Zahrn stated that they are not and are only responsible for the County highways.
