### MINUTES

### SANGAMON COUNTY BOARD

### **JUNE 2, 2008**

The Sangamon County Board met in Reconvened Adjourned September Session on June 2, 2008 in the County Board Chambers. Mr. Montalbano gave the Invocation and Mr. O'Neill led the Board in the Pledge of Allegiance.

#### **ROLL CALL**

Chairman VanMeter asked the Clerk to call the roll. There were 25 Present – 4 Absent. Mr. Bunch, Mrs. Douglas Williams, Mr. Fraase, and Mr. Preckwinkle were all excused.

### PROCLAMATIONS

Mrs. Musgrave presented a Proclamation to the Springfield Civic Garden Club in honor of National Garden Week. Sally Noble President of the Garden Club accepted the honor and thanked the Board on behalf of the entire Garden Club. She encouraged everyone to go through some of the public buildings this week, because they have designers in the libraries at Lincoln's Home and at Washington Park who will have arrangements in their buildings to celebrate National Garden Week.

Mrs. Long presented a Proclamation to 183<sup>rd</sup> Firefighters Fighter Wing at the Springfield Capital Airport. Mrs. Long challenged the Board Members to help save them by sending around petitions to get signatures and to return them to her by the end of July. The petition is to keep the firehouse at the 183<sup>rd</sup> Fighter Wing at Abraham Lincoln Capital Airport open. They provide fire and emergency service for the Airport and Central Illinois. They are asking that the Air Force place aircraft at the 183<sup>rd</sup> Fighter Wing Air National Guard Base at Abraham Lincoln Capital Airport. The funding will be secured to ensure that the 183<sup>rd</sup> Fire Department will be able to provide uninterrupted fire and emergency response for the Airport and continue to provide top-notch emergency services to Central Illinois and the Nation.

Kevin Schott, Senior Union Firefighter of the 183<sup>rd</sup> Fire Department, was present to speak on their behalf. He stated that in March the County Board wrote a support letter he was able to take to Washington and hand deliver to Senator Durbin, Senator Obama, Representative LaHood, Representative Shimkus, and Representative Hare's Office on Capitol Hill. Mr. Schott thanked the Board for that letter. In 2005 it was decided by Congress that the 183<sup>rd</sup> would lose their F16 Flying Mission. With that the Fire Department goes away as well. They have been lobbying quite strenuously to get that changed and get an additional flying mission of some type into the 183<sup>rd</sup>. For the past 60 years they have answered the call for every job they have been asked to do whether it is from the Governor or the President of the United States. They feel they deserve a flying mission and want to secure the mission to ensure its viability in this community. He stressed that they would continue to fight up to the last minute. Mr. Schott thanked the Board for their time.
