

RESOLUTION 3-1

WHEREAS, the budget for the County Highway Fund for FY 2004-2005 provided funding for the purchase of Gradall excavator; and,

WHEREAS, bids were opened on July 25, 2005 at the Sangamon County Highway Department; and,

WHEREAS, two bids were received and the low bid of \$271,089.00 was submitted by G. W. Van Keppel, St. Louis, MO for a Gradall Model XL4100 II, which included a trade in allowance of \$14,000.00 for a Gradall Model G660E excavator.

WHEREAS, for budgetary reasons it is necessary to finance a portion of this purchase beyond this fiscal year; and,

WHEREAS, G. W. Van Keppel, St. Louis, MO was the lowest bidder with financing, per specifications, with a fixed Annual Percentage Rate of 4.499%; and,

WHEREAS, the loan is a three year contractual agreement, with a deposit down in the amount of One Hundred Seventeen Thousand Forty Nine Dollars and 50/100 Cents (\$117,049.50) made payable to G. W. Van Keppel, St. Louis, MO, from County Highway Fund; and,

WHEREAS, a total of One Hundred Twenty Six Thousand Thirty Nine Dollars and 50/100 Cents (\$126,039.50) must be borrowed, with three annual installments made to G. W. Van Keppel, St. Louis, MO, the first payment to be paid December 15, 2005, the second payment to be paid on December 15, 2006, and the third payment to be paid December 15, 2007 in the amount of Forty Two Thousand Thirteen Dollars and 17/100 Cents (\$42,013.17) each, which amount includes all accrued interest at an annual rate of 4.499%.

NOW THEREFORE BE IT RESOLVED, by the County Board of Sangamon County, at its Regular Reconvened Adjourned June Session assembled this 9<sup>th</sup> day of August, A.D., 2005 that the Sangamon County Highway Department is hereby authorized to order a Gradall Model XL4100 II at a net price of \$257,089.00 from G. W. Van Keppel, St. Louis, MO.
