RESOLUTION NUMBER 8-1
OF THE SANGAMON COUNTY BOARD OF SANGAMON COUNTY, ILLINOIS
ADOPTING THE 2004 ILLINOIS STATE PLUMBING CODE AND THE 2005
NATIONAL ELECTRICAL CODE

PREAMBLE

WHEREAS, the Sangamon County Board believes that it is in the best interest of the general health, safety, comfort and welfare of the people of Sangamon County, Illinois to adopt updated versions of building codes; and

WHEREAS, the 2004 Illinois State Plumbing Code is available for adoption; and

WHEREAS, the 2005 National Electrical Code is available for adoption; and

WHEREAS, The Sangamon County Building Code Board of Appeals has recommended that the Sangamon County Board adopt the 2004 Illinois State Plumbing Code and the 2005 National Electrical Code,

WHEREAS, the Public Health, Safety and Zoning Committee of the Sangamon County Board recommends that the Sangamon County Board adopt the 2004 Illinois State Plumbing Code and the 2005 National Electrical Code.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE COUNTY BOARD OF SANGAMON COUNTY, ILLINOIS IN SESSION THIS 12TH DAY OF JULY, 2005, AS FOLLOWS:

Section 1. The chapter 15.05 of Title 15, BUILDING AND CONSTRUCTION, is hereby amended by the adoption of the 2005 National Electrical Code.

Section 2. That chapter 15.05 of Title 15, BUILDING AND CONSTRUCTION, is hereby amended by the adoption of the 2004 Illinois Plumbing Code.

Section 3. That the 2005 National Electrical Code shall become effective 10 days after posting by the Sangamon County Clerk.

Section 4. That the 2004 Illinois State Plumbing Code shall become effective 10 days after posting by the Sangamon County Clerk.

Section 5. That the Sangamon County Clerk is directed to publish this Resolution as required by law.
