WHEREAS, per Illinois Statute 55 ILCS 5/5-1103, Court Security fees can reach a maximum of \$25.00 – per traffic ticket that involve court appearances. Currently Court Security receives \$11.00 fee for these types of tickets; and,

WHEREAS, the Circuit Court would like to increase the fee to \$20.00 for Court Security costs; and,

NOW THEREFORE BE RESOLVED, by the County Board of Sangamon County at its Regular Reconvened Adjourned June Session assembled this 12<sup>th</sup> day of September, 2006 that the Sangamon County Circuit Court is hereby authorized to change the breakdown of the fee structure of Traffic Tickets that require a court appearance and increase Court Security fee's from \$11.00 to \$20.00 effective \_\_\_\_\_, 2006 (see attached).
