- Current fee - \$ 6.00 – increase to \$10.00
- Current fee - \$10.00 – increase to \$15.00
- Current fee - \$15.00 – increase to \$20.00

NOW THEREFORE BE RESOLVED, by the County Board of Sangamon County at its Regular Reconvened Adjourned June Session assembled this 12th day of September, 2006 that the Sangamon County Circuit Court is hereby authorized to increase the fee's on civil filings effective _____, 2006 (see attached).
