

RESOLUTION 2-1

WHEREAS, the stainless steel conveyor utilized by the County Highway Department to load deicing material into the salt dome is in need of major repair; and,

WHEREAS, the stainless steel conveyor is a specialized piece of equipment that was purchased in 1997; and,

WHEREAS, repair of the stainless steel conveyor is expected to require a period of 6 weeks after approval of the contract, and;

WHEREAS, completion of the repairs by the end of October 2008 is necessary to ensure proper supply and distribution of road salt for the safe operation of vehicles upon the roads and highways in and about Sangamon County, and;

WHEREAS, emergency approval of the repair is needed to insure completion before the conveyor is needed to fill the dome before the winter season; and,

WHEREAS, the conveyor was picked up by the original manufacturer, YARGUS MANUFACTURING, INC. for evaluation and repair; and,

WHEREAS, the total estimated repair from YARGUS MANUFACTURING, INC. exceeded \$20,000.00 with \$5,130.00 in repairs already completed which necessitated additional quotes being sought; and,

WHEREAS, there were two quotes obtained for the remaining repairs to the conveyor with the low quote of \$19,938.46 from KIMCO, USA bringing the total cost of the repair to \$25,068.46.

NOW THEREFORE BE IT RESOLVED, by the County Board of Sangamon County at its ANNUAL STATUTORY MEETING assembled this 9<sup>th</sup> day of September, A.D., 2008, that the \$19,938.46 quote from KIMCO, USA for additional repair of the stainless steel conveyor is approved.

BE IT FURTHER RESOLVED, that the \$5,130.00 for initial evaluation and repairs completed by YARGUS MANUFACTURING, INC. is also approved.
