

RESOLUTION 15-1

WHEREAS, the Sangamon County Circuit Court's legal research contract with West Publishing Corporation/Thomson Reuters Enterprise Centre GmbH (herein "Westlaw") for County Legal Researchers (i.e., the court, the Public Defender's Office, and the State's Attorney's Office) ends on December 31, 2023; and

WHEREAS, purchasing internet-based legal research services for County Legal Researchers eliminates the need for Sangamon County to expend funds to maintain the former law library, a library comprised primarily of legal material in book form, and the need to purchase the vast majority of legal books formerly purchased for County Legal Researchers; and

WHEREAS, Westlaw alone responded to the Circuit Court's RFP seeking internet-based legal research services for County Legal Researchers; and

WHEREAS, the Circuit Court prefers to remain with Westlaw as the vendor for internet-based legal search services because Westlaw has performed well under past contracts and County Legal Researchers are familiar with Westlaw products; and

WHEREAS, Westlaw's Order Form (attached hereto as Exhibit A) includes the following monthly pricing schedule for internet-based legal research for sixty (60) County Legal Researchers: \$6,436.18 for FY24, \$6,575.15 for FY25, \$6,717.03 for FY26, \$6,862.73 for FY27, \$7,011.51 for FY28; and

WHEREAS, the Westlaw Order Form (Exhibit A) grants Sangamon County the right to terminate services for County Legal Researches after FY26 and FY27; and

WHEREAS, Westlaw has also offered, through a second Westlaw Order Form (attached hereto as Exhibit B), to provide its Drafting Assistant for Government service for one County Legal Research for a one-year term for \$119 per month (\$1,428 for the year); and


WHEREAS, it is envisioned that the SAO's Civil Division will use the Drafting Assistant service on various county contract drafting and briefing assignments and thereafter determine if the efficiencies and accuracy of the service warrant continued or further use; and

WHEREAS, through a third Westlaw Order Form (attached hereto as Exhibit C), Westlaw has offered to renew its existing contract and provide specified, printed legal books for the judges' use over a five-year period beginning February 1, 2024, at a charge of approximately \$555 per month; and

WHEREAS, through a fourth Westlaw Order Form (attached hereto as Exhibit D), Westlaw has offered to renew its existing contract and provided specified, printed legal

books for the State's Attorney's Office's use over a five-year period beginning March 1, 2024, at a charge of approximately \$82 per month; and

WHEREAS, the Circuit Court desires that Sangamon County accept the aforementioned Westlaw offers.

NOW, THEREFORE, BE IT RESOLVED by Sangamon County this 19th day of December, 2023, that the Sangamon County Circuit Court is hereby authorized to: (a) execute the Westlaw Order Form attached hereto as Exhibit A and thereby enter into a contract with Westlaw for internet-based legal research services for sixty (60) County Legal Researchers; (b) execute the Westlaw Order Form attached hereto as Exhibit B and thereby enter into a one-year contract with Westlaw for its Drafting Assistant service for (1) County Legal Researcher; (c) execute the Westlaw Order Form attached hereto as Exhibit C and thereby enter into a five-year contract to obtain legal books for judges; and (d) execute the Westlaw Order Form attached hereto as Exhibit D and thereby enter into a five-year contract to obtain legal books for the State's Attorney's Office.

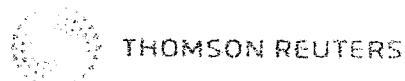
