WHEREAS, County policies and procedures require both the assigned oversight committee and the County Board to approve all requests to procure goods and/or services costing \$30,000 or more; and,

WHEREAS, the Department of Public Health wishes to procure goods and/or services from Chef Units for the purpose of providing renovation services for a transit van to a mobile medical unit in the amount of approximately \$63,000.00; and

WHEREAS, this purchase will allow Public Health to provide renovation of a van into a mobile medical unit for community activities in Sangamon and Menard; and

WHEREAS, as documented by the approval of this resolution, Public Health Committee has approved the Public Health Department's request to procure the items specified and the committee recommends that the County Board approve procurement of the same, and;

The Elected Official/Department Head is authorized to sign required documents to execute the provision of this procurement.
