WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of the Sheriff's Office wishes to apply for and accept an a grant from Illinois Law Enforcement Training and Standards Board for the FY24 Officer Recruitment and Retention Grant Program program in the amount of approximately \$162,722.78 ; and

WHEREAS, this grant will allow the Sheriff's Office to provide provide some temporary recruitment and retention bonuses and media/marketing recruitment supplies ; and

WHEREAS, as documented by the approval of this resolution, the Jail Committee and the Finance Committee have approved the the Sheriff's Office Department's request to apply for the ILETSB grant and the committees recommend that the County Board approve the acceptance of this grant, if awarded by Illinois Law Enforcement Training and Standards Board .

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 19th day of December , 2023 , approves the acceptance of the ILETSB grant, which is detailed above, if the grant is awarded to the County by Illinois Law Enforcement Training and Standards Board . The County Administrator is authorized to sign required grant documents to execute the agreement for this grant.
