WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of Elections wishes to apply for and accept an a grant from State of Illinois (distributed by IL State Board of Elections) for the 2024 Illinois Voter Registration State Grant (IVRS) program in the amount of approximately \$81,358; and

WHEREAS, this grant will allow Elections to provide maintenance and other costs associated with the voter registration system; and

WHEREAS, as documented by the approval of this resolution, Election Oversight Committee and the Finance Committee have approved the Elections Department's request to apply for the 2024 Illinois Voter Registration State Grant (IVRS) grant and the committees recommend that the County Board approve the acceptance of this grant, if awarded by State of Illinois (distributed by IL State Board of Elections).

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 19th day of December, 2023, approves the acceptance of the 2024 Illinois Voter Registration State Grant (IVRS) grant, which is detailed above, if the grant is awarded to the County by State of Illinois (distributed by IL State Board of Elections). The County Administrator is authorized to sign required grant documents to execute the agreement for this grant.
