RESOLUTION AMENDING THE SANGAMON COUNTY CODE BY AMENDING TITLE 15 BUILDINGS AND CONSTRUCTION

WHEREAS, Sangamon County has the authority to promulgate rules and regulations governing the construction and alteration of all buildings and structures to protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to this authority, the county has adopted Chapter 15.05 of the Sangamon County Code, entitled Building, Construction, Alteration, and Maintenance, which contains permit requirements, fee schedules, and penalty provisions; and

WHEREAS, after gathering data concerning similarly situated governing bodies, and after receiving input from stakeholders, including local builders, the Zoning and Land Use Committee has determined that Chapter 15.05 of the Sangamon County Code should be revised, all as shown on Exhibit A attached hereto, so that its requirements: (a) are more closely aligned with similarly situated governing bodies; (b) provide greater revenue to support the Building and Zoning Department from those directly using its services; and (c) do not place and undue burden on those wishing to improve their real estate.

NOW THERFORE BE IT RESOLVED by the members of the Sangamon County Board this 10th day of December, 2024, that it agrees with the aforesaid determination of the Zoning and Land Use Committee and, accordingly, Chapter 15.05 of the Sangamon County Code is hereby revised and amended as set forth in Exhibit A hereto, effective January 1, 2025.

- *A hardship waiver may be available for owner-occupied residences with a fair market value not to exceed \$75,000 with a minimum permit fee of \$100.
- *A hardship waiver may be available for owner-occupied residences that have been affected by a natural disaster or total loss fire. Permit waiver up to 50% per the administrator's discretion.
- *Government accessory structures not intended for occupancy may waive the permit fee.
- *Disabled veterans may waive permit fees for construction or alteration to support said disability per state statute (proof required).
- *Veterans receive a 25% discount.
- *All square footage fees are subject to an annual CPI increase.

Article 15.05-IV Violations

15.05.210 Violation Penalties

Any person who violates a provision of the codes referenced in Section 15.05.070 or fails to comply with any of the requirements thereof, or who erects, constructs, alters or repairs a building or structure in violation of the approved construction documents or directive of the building official or code official, or of a permit or certificate issued under the provisions of the codes, commits a petty offense.

Any person who commences construction without having made application to the Department of Building Safety and received authorization from said department to begin said construction shall be subject to an application fee of one hundred fifty percent (150%) of the normal fee.

The state's attorney may bring action to enforce compliance of the requirements of this ordinance by filing an action before the Sangamon County Ordinance Violation Hearing Department or by filing an action in Sangamon County Circuit Court requiring conformance with this article, fines, fees and costs for violation of this article or such other order as the Court or hearing officer may deem necessary.
