WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of Land of Lincoln Workforce Alliance wishes to apply for and accept an a grant from Illinois Department of Commerce and Economic Opportunity for the PY' 2024 Supplemental State Funding program in the amount of approximately \$398,182; and

WHEREAS, this grant will allow Land of Lincoln Workforce Alliance to provide Business Services and Employee trainings for manufacturers; and

WHEREAS, as documented by the approval of this resolution, The Community Resources Committee and the Finance Committee have approved the Land of Lincoln Workforce Alliance Department's request to apply for the PY' 2024 Supplemental State Funding grant and the committees recommend that the County Board approve the acceptance of this grant, if awarded by Illinois Department of Commerce and Economic Opportunity.
