## RESOLUTION 26-1

WHEREAS, by Resolution 6-1 of the August 13, 2024, Board meeting, Sangamon County proposed the creation of a Special Service Area for the levy of a tax for a special services area for improved ambulance services for that portion of the Virden Fire Protection District (FPD) lying in Sangamon County; and

WHEREAS, Sangamon County has followed the procedures set forth in the Special Service Area Tax Law, 35 ILCS 200/27-5 through 200/27-125, including holding a timely public hearing to obtain input from interested persons regarding the proposed SSA, and the input provided was generally favorable to the creation of the proposed SSA; and

WHEREAS, in addition to the mandated hearing, the question of the advisability of forming the proposed SSA was placed on the ballots of voters in the proposed SSA during the November 5, 2024, general election, and over 69% of those who voted on the question were in favor of the creation of the proposed SSA.

NOW, THEREFORE, BE IT RESOLVED by the Sangamon County Board on this 12th day of November, 2024, that, given the apparent assent of the majority of those who will be directly affected by the creation of the proposed SSA, and contingent upon no objection petition complying with Section 27-55 of the Special Service Area Tax Law, 35 ILCS 200/27-55, being filed with the Sangamon County Clerk on or before December 20, 2024, a Special Service Area for improved ambulance services for that portion of the Virden FPD lying in Sangamon County, Illinois, is hereby created for the area whose boundary is legally described as follows:

Thence East along Sangamon / Macoupin County Line and the South Line of Sections 32, 33, 34, 35, 36 in T13N, R7W of the 3rd P.M to the Southeast corner of said Section 36; Thence Continuing East along the Sangamon / Macoupin County Line and the South Line of Sections 31, 32, 33, 34, 35, 36 in T13N, R6W of the 3rd P.M to the Southwest corner of said Section 31 in T13N, R5W of the 3rd P.M. said point also being the Northwest corner of Montgomery County; Thence continuing East along the Sangamon / Montgomery County Line and the South

line of Sections 31, and 32 in T13N, R5W of the 3rd P.M. to the Point of Beginning

Lots 45 and 46 in Rolling Meadows Plat 10 Subdivision of Section 27, T13N, R6W of the 3rd P.M.

Sangamon County shall henceforth levy a special tax on real estate within said area, said tax to be extended in any year not to exceed thirty-five cents (\$0.35) per one hundred dollars (\$100.00) of equalized assessed value or as allowed by law.

To the extent necessary to create the desired Special Service Area for improved ambulance services as set forth above under the Special Service Area Tax Law, it is the intention of the Board that this Resolution will for all purposes be deemed to be and shall constitute the enactment of an ordinance as referenced in Section 27-40 of the Special Service Area Tax Law, 35 ILCS 200/27-40, by the Board which establishes said Special Services Area, as it is the intent of the Board to approve, adopt, and ordain the requisite resolution or ordinance which will establish the desired Special Services Area.
