

RESOLUTION *2-1*  
Section 07-00164-04-FP

**WHEREAS**, plans are prepared for the grade separation of Iron Bridge Road (CH 22) over the Union Pacific Railroad and the grade separation of Woodside Road (CH 23) under the Union Pacific Railroad; and,

**WHEREAS**, the estimated cost of construction is \$50,128,908; and,

**WHEREAS**, the estimated cost of construction engineering is \$2,200,000; and,

**WHEREAS**, the project will be funded with Federal Surface Transportation Urban funds not to exceed \$9,600,000, Federal High Priority Project funds not to exceed \$330,460, Grade Crossing Protection Funds not to exceed \$15,922,888, State of Illinois funds not to exceed \$1,818,597, County Motor Fuel Tax funds will fund \$20,000,000 and the remaining balance will be paid from County Matching funds; and,

**WHEREAS**, it is necessary for Sangamon County to execute a "Local Agency Agreement for Federal Participation" with the State of Illinois for projects using Federal Funds; and,

**NOW THEREFORE BE IT RESOLVED**, by the County Board of Sangamon County at its **Regular Reconvened Adjourned September Session**, assembled this 8<sup>th</sup> day of October, A.D., 2024, that there is hereby appropriated the sum of \$20,000,000.00 from the County Motor Fuel Tax Fund to pay a portion of the local agency match for the proposed grade separation project, known as County Section 07-00164-04-FP; and,

**BE IT FURTHER RESOLVED**, the "Local Agency Agreement for Federal Participation" between Sangamon County and the Illinois Department of Transportation which depicts the breakdown of the funds for construction, be approved; and,

**BE IT FURTHER RESOLVED**, by the County Board of Sangamon County that the Chairman of the County Board is hereby authorized and directed to sign said Agreement on behalf of Sangamon County.
