WHEREAS, Sangamon County, through a planning study concluded that the Springfield-Sangamon County Transportation Center should include a parking structure, an Amtrak Station, a Sangamon Mass Transit District Transfer Facility, and a County Square; and,

WHEREAS, collectively, the facility will be known as The HUB; and,

WHEREAS, in order to accommodate construction of The HUB, it is necessary to relocate existing electric and fiber services currently housed on/under existing Adams Street between 9th Street and the 10th Street rail corridor; and,

WHEREAS, relocation of some of these facilities requires Sangamon County to grant a Permanent Easement twenty-five feet in width along the east property line of the existing Sangamon County complex and parallel to the 10th Street rail corridor to City Water, Light and Power; and,

WHEREAS, the cost associated with the relocation of a transformer, circuit and fiber is estimated to be \$298,546.40 with the cost being attributable to the project and the Sangamon County reimbursement from the project would be according to the established cost share and is currently estimated to be \$73,208.00; and,

WHEREAS, a Permanent Easement has been drafted for twenty-five foot area parallel to the 10th Street rail corridor.

NOW THEREFORE BE IT RESOLVED, by the County Board of Sangamon County at its Regular Reconvened Adjourned September Session, assembled this 11th day of March, A.D., 2025 that the \$298,546.40 cost associated with the relocation is approved and will be paid to City Water, Light and Power prior to relocation work commencing; and,

BE IT FURTHER RESOLVED, that the Permanent Easement is approved and the Chairman of the County Board of Sangamon County is hereby authorized and directed to sign said Permanent Easement on behalf of Sangamon County.


