**WHEREAS**, plans are underway for the reconstruction of Woodside Road (County Highway 23) from ¼ mile west of the proposed intersection of MacArthur Boulevard with Woodside Road (County Highway 23) east to Toronto Road (200 feet east of N. Lake Road) including underpasses at the Union Pacific Railroad and Interurban Trail; and,

**WHEREAS**, plans are to be prepared for the extension of MacArthur Boulevard from Woodside Road (County Highway 23) south to Iron Bridge Road (County Highway 22) including overpasses at the Union Pacific Railroad and Interurban Trail; and,

**WHEREAS**, a resolution was passed at the September 11, 2007 meeting of the Sangamon County Board approving a Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. to perform surveys, prepare right of way documents, and to prepare roadway and structure plans and documents for construction bidding for both sections with the east limits as the intersection of Carole Road; and,

**WHEREAS**, a supplemental resolution was passed at the January 8, 2008 meeting of the Sangamon County Board approving a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. to perform surveys, prepare right of way documents, and to prepare roadway and structure plans and documents for construction bidding for the Woodside Road section with the east limits modified as 200 feet east of N. Lake Road; and,

**WHEREAS**, resolutions were passed at the June 2, 2008 meeting of the Sangamon County Board approving a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. to perform right of way appraisal, review appraisal and right of way negotiations on both sections; and,

**WHEREAS**, supplemental resolutions were passed at the July 9, 2013 meeting of the Sangamon County Board approving a Supplemental Preliminary Engineering Services Agreements for both sections with HANSON PROFESSIONAL SERVICES, INC. to perform surveys, prepare right of way documents, perform right of way appraisal, review appraisal, perform right of way negotiations and to prepare roadway and structure plans and documents for construction bidding to accommodate double tracking of the railroad corridor for the project with the east limits modified as 200 feet east of N. Lake Road; and,

**WHEREAS**, at the June 14, 2016 meeting of the Sangamon County Board, resolutions were passed for both sections for design changes resulting from the removal of the retaining wall, comments received by the Union Pacific Railroad, and changes made during right of way negotiations requiring a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. to perform surveys, prepare right of way documents, perform right of way appraisal, review appraisal, perform right of way negotiations and to prepare roadway and structure plans and documents for construction bidding, to represent the County at Illinois Commerce Commission hearings, and pay for the Union Pacific Railroad review; and,

**WHEREAS**, at the December 10, 2019 meeting of the Sangamon County Board, a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. was approved to finalize roadway and structure plans and documents for construction bidding as a combined single project, complete coordination with the Springfield Park District for modifications on the Interurban Trail and to represent the County at Illinois Commerce Commission hearings, with the cost not to exceed an additional \$130,693 for the Woodside Road section and \$18,301.00 for the Iron Bridge Road section; and,

**WHEREAS**, a resolution was passed at the June 9, 2020 meeting of the Sangamon County Board due to additional comments and reviews by the Union Pacific Railroad and their consultants, resulting in a shift of both the proposed overpass structure and the proposed underpass structure as well as resulting track spacing requirements, a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. has been prepared in an amount not to exceed an additional \$606,748 for completion of the proposed project plans; and,

**WHEREAS**, a resolution was passed at the May 11, 2021 meeting of the Sangamon County Board for an additional sum of money to complete the Union Pacific Railroad engineering review and to cover attorney's fees for the proceedings before the Illinois Commerce Commission, a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. has been prepared in an amount not to exceed an additional \$110,000; and,

**WHEREAS**, a settlement agreement was reached between Sangamon County and the Union Pacific Railroad for the construction of the Woodside Road underpass and the Iron Bridge Road overpass in June 2022, resulting in the need to update temporary easements along Woodside Road and Iron Bridge Road, update the plans and specifications to current standards, reimburse the Union Pacific for plan reviews, pay invoices for Hinshaw & Culbertson LLP, and make HANSON PROFESSIONAL SERVICES whole for extra efforts during the litigation of the Illinois Commerce Commission decision by the Union Pacific Railroad, a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. has been prepared in an amount not to exceed \$50,000 for right-of-way engineering and a Supplemental Preliminary Engineering Services Agreement with HANSON PROFESSIONAL SERVICES, INC. has been prepared in an amount not to exceed an additional \$311,519; and,

**WHEREAS**, now that the project is under construction, a supplemental engineering contract has been prepared to cover consultant services such as shop drawing and cut sheet review as well as constructability consultation services with HANSON PROFESSIONAL SERVICES, INC. in the amount of \$61,000.

**NOW THEREFORE BE IT RESOLVED**, by the County Board of Sangamon County at its **Regular Reconvened Adjourned September Session**, assembled this 10th day of February, A.D. 2026, that the supplemental engineering contract in the amount of \$61,000 with HANSON PROFESSIONAL SERVICES, INC. is approved; and,






