#### **MINUTES**

#### SANGAMON COUNTY BOARD

## **FEBRUARY 9, 2016**

The Sangamon County Board met in Reconvened Adjourned September Session on February 9, 2016 in the County Board Chambers. Chairman Van Meter called the meeting to order at 7:00 p.m. Mr. Smith gave the Invocation and Mr. DelGiorno led the County Board in the Pledge of Allegiance.

#### **ROLL CALL**

Chairman Van Meter asked County Clerk Gray to call the roll. There were 28 Present – 0 Absent.

#### **PRESENTATION**

States Attorney John Milhiser recognized current Child Advocacy Center Director Shirley Johnson, former Director Betsy Goulet and Vice-Chair of Friends of the CAC Ryan Cadagin. Betsy Goulet is also the current Chair of the Friends of the CAC. Friends of the Child Advocacy Center presented a check in the amount of \$50,000 to the Child Advocacy Center to assist with the purchase of the new CAC building at 11<sup>th</sup> & Monroe in Springfield. Mr. Milhiser also recognized former Assistant State's Attorney Sheryl Essenburg who was assigned and who prosecuted all of the CAC cases.

Chairman Van Meter recognized a group of boy scouts in the audience.

Resolution 10 approves the technology company to provide equipment. Resolution 9 allows them to communicate the current technology with new technology.
