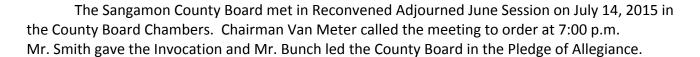

ROLL CALL

APPOINTMENT OF COUNTY BOARD MEMBER FOR DISTRICT #17

A motion was made by Chairman Van Meter to nominate Annette Fulgenzi as County Board Member for District #17. A voice vote was unanimous. Mrs. Fulgenzi was sworn in by County Clerk Don Gray.

PROCLAMATION

Mr. Mendenhall presented a Proclamation to Andy Goleman recognizing his many accomplishments on the County Board and his dedication and loyalty to the residents of District #4.

Mr. Goleman accepted the Proclamation. He stated it was a pleasure to serve on the Sangamon County Board for 21 years. He remembers back in 1993 when Bill Clark, Bob Nadalini, Dick Hall and Larry Bomke came to visit him one day and said they would like to see him run for county board.
