He announced that Mr. Zahrn has been honored as the Illinois Association of County Engineers Zone 2 Engineer of the Year at the 101st Transportation Highway Engineering Conference held on February 5, 2015. The T.H.E. conference was started in 1914 as a training school for newly created county superintendents of highways and is held annually at the University of Illinois campus in Urbana/Champaign, Illinois. This position would eventually become the county engineer position we know today. Sangamon County celebrated its 100 year anniversary of having a county engineer. Each year the Illinois Association of County Engineers recognizes a county engineer from three zones that divide the 102 counties in Illinois. Zone 2 is comprised of 34 counties in Central Illinois that stretch from the Mississippi River to the Indiana border. The award recognizes county engineers that are active in the community, active in the Illinois Association of County Engineers. Tim Received a plaque and congratulations from Williamson County Engineer and IACE President Greg Smothers. The Illinois Association of County Engineers also nominated Tim as their candidate for the National Association of County Engineers Urban Engineer of the Year. The announcement will be made at the national convention in April.

Mr. Zahrn addressed the County Board. He stated these awards are nominated by his peers of other county engineers, which really makes it special. Having support from the County Board and a great staff make these types of things possible. He thanked them for the recognition.
