MINUTES

SANGAMON COUNTY BOARD

OCTOBER 6, 2015

The Sangamon County Board met in Reconvened Adjourned September Session on October 6, 2015 in the County Board Chambers. Chairman Van Meter called the meeting to order at 7:00 p.m. Mr. Smith gave the Invocation and Mr. Ratts led the County Board in the Pledge of Allegiance.

ROLL CALL

Chairman Van Meter asked County Clerk Gray to call the roll. There were 28 Present – 1 Absent. Mr. Tjelmeland was excused.

PROCLAMATION

Linda Fulgenzi presented a Weatherization Day Proclamation in recognition of the Weatherization Assistance Program. Director of Community Resources Sharmin Doering accepted the Proclamation. She thanked the County Board for recognition of this program. It provides construction services for low income families, and it is a self-sufficiency program that enables the families to save money for other basic needs such as food, clothing and shelter. It also releases the burden on community action agencies from having to provide those things.

Mr. Preckwinkle acknowledged a local business owner, Mike Murphy, owner of Charlie Parker's restaurant. Mike is currently in a national contest called Thomas' Hometown Breakfast Battle. Out of around 137 local restaurants to start with, he is currently leading in first place. With a little support from the community they can bring the first place victory home to Springfield and Sangamon County.

Mr. Murphy addressed the County Board. He stated they were approached by Thomas Company about 4 months ago to come up with a recipe that had a hometown flavor using their product. So, he immediately thought of the horseshoe. He made a breakfast horseshoe on an english muffin and submitted it. Voting started on September 14th. They cut it down to 16 after two weeks of voting, and they made that cut. Last Sunday they cut it again down to eight, and they made that cut as well. This Sunday they will cut it to four. Unlike the elections you are involved in, every week they start over. They throw out all the old votes and start over from scratch. Today, for the first time in the contest, they have taken over first place. They are asking for help from the community. You can go to www.thomasbreakfastbattle.com or to Charlie Parker's Facebook to click on the links to register and vote. Once registered, you can vote one time per day. He thinks they do need to make the Springfield horseshoe nationally known as the champion it well deserves. There is a \$25,000 first prize to the winner. He has 23 employees and he has vowed to give each one of them a \$1,000 bonus if they win. There is some excitement among them, especially today when they took over first place. He asked that everyone go to his Facebook page and share the information and send Emails at their place of work if they can. He expressed his appreciation. As a citizen of Sangamon County, he thanked the County Board for the way they govern. He stated they are the shining example of how to have government in central Illinois.
