WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of Land of Lincoln Workforce Alliance wishes to apply for and accept an a grant from Illinois Department of Commerce and Economic Opportunity for the Trade and Trade Case Management program in the amount of approximately \$55,000; and

WHEREAS, this grant will allow Land of Lincoln Workforce Alliance to provide education, training and career related activities; and

WHEREAS, as documented by the approval of this resolution, the Finance Committee has approved the Land of Lincoln Workforce Alliance Department's request to apply for the Trade and Trade Case Management grant and the committee recommends that the County Board approve the acceptance of this grant, if awarded by Illinois Department of Commerce and Economic Opportunity.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 8 day of December, 2020, approves the acceptance of the Trade and Trade Case Management grant, which is detailed above, if the grant is awarded to the County by Illinois Department of Commerce and Economic Opportunity. The County Administrator is authorized to sign required grant documents to execute the agreement for this grant.

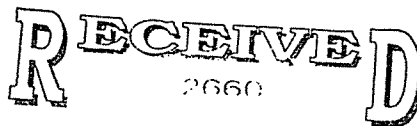
