

Resolution 10-1

WHEREAS, The Sangamon County Board has the duty and authority imposed by law to reapportion the County of Sangamon following the decennial census so that each member of the county board represents a substantially equal number of inhabitants, pursuant to 55 ILCS 5/2,3002; and

WHEREAS, The Sangamon County Board is required to complete said reapportionment by December 31, 2021, pursuant to 55 ILCS 5/2,3002 ; and

WHEREAS, The COVID-19 pandemic has caused significant delays in receiving the decennial census data; and

WHEREAS, The decennial data is currently expected to become available on August 12, 2021; and

WHEREAS, Upon receiving the decennial data, Sangamon County will begin the reapportionment process; and

WHEREAS, The Sangamon County Board wishes that interested residents and community groups are allowed to submit oral and/or written testimony to the board; and

WHEREAS, The Sangamon County Board directs staff to schedule and promote six opportunities for the public to address the county board; and

WHEREAS, Public comment will focus on the reapportionment efforts under the jurisdiction of the County Board; and

WHEREAS, residents of Sangamon County and community groups are encouraged to participate in the reapportionment process.

NOW, THEREFORE, BE IT RESOLVED that the Members of the Board of Sangamon County, Illinois, in session this **10th day of August 2021** that the 2021 Reapportionment public hearing schedule is adopted as follows:

Public Hearing 1: Special Election Oversight Committee Meeting; August 25, 2021, at 5:30 PM in the Sangamon County Board Chambers.


