ORDINANCE NO. 11-1

ORDINANCE ADDING TERRITORY TO THE LINCOLN-  
LOGAN COUNTY ENTERPRISE ZONE

WHEREAS, the City of Lincoln, the County of Logan, the Village of Elkhart, the County of Sangamon and the County of DeWitt (“Units of Government”) each adopted respective ordinances, as amended, establishing and designating an Enterprise Zone encompassing contiguous portions of the City of Lincoln, the County of Logan, the Village of Elkhart, the County of Sangamon and the County of DeWitt (such zone, as amended, being the “Enterprise Zone”); and

WHEREAS, the Units of Government each entered into an intergovernmental agreement, as amended, which identifies the responsibilities of each party; and

WHEREAS, the Units of Government have received a request to add additional territory in incorporated Lincoln, the Village of Hartsburg, the City of Atlanta, the Village of New Holland and unincorporated Logan County to the zone in order to assist Hartsburg Grain Company, East Lincoln Farmers Grain Co., Taloma Farmers Grain Co., and Elkhart Grain Company;

**BE IT ORDAINED BY THE COUNTY OF SANGAMON, ILLINOIS THAT**

**Section 1** – The Legal Description of Zone described in adopted respective ordinances the area Enterprise Zone is hereby amended by adding additional property to the Zone as described in Exhibit A attached, hereto and incorporated herein which is further depicted in the map attached hereto as Exhibit B and which is made part hereof by this reference (the “Amended Territory”); and that the Amended Territory is hereby designated part of the Enterprise Zone pursuant to and in accordance with the Act;

**Section 2** – The Intergovernmental Agreement between Units of Government adopted, as amended, is hereby amended to include the additional property to the Zone as described in Exhibit C

**Section 4** – This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law, and from and after the designation by the Illinois Department of Commerce and Economic Opportunity of said additional territory contained herein as part of the Lincoln-Logan County Enterprise Zone.
