WHEREAS, the Sangamon County Circuit Clerk received approval from the Supreme Court to implement an Electronic Citation program in September 2015; and,

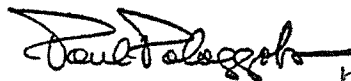

WHEREAS, the Circuit Clerk has received legal review approval from Assistant State's Attorney, Joel Benoit and,

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 13th day of October, 2020, hereby accepts this quotation and invoice, and authorizes the Circuit Clerk to proceed as such with a Purchase Order to complete this integration.

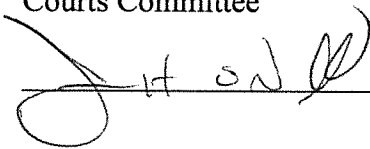
