
RESOLUTION AMENDING THE SANGAMON COUNTY CODE BY

BUILDING AND CONSTRUCTION

WHEREAS, Sangamon County has the authority to adopt resolutions and to promulgate rules and regulations governing the construction and alteration of all buildings and structures to protect the public health, safety and welfare of its citizens; and


WHEREAS, as the current 2006 International Building Code series was adopted by the county in 2009, the adoption of provisions of the 2018 International Building Code series will better protect county citizens by requiring modern building practices and materials; and

WHEREAS, as the current 2005 National Electrical Code was by the county in 2009, the adoption of provisions of the 2017 National Electrical Code will better protect the county citizens by requiring modern electrical practices and materials; and

NOW THEREFORE BE IT RESOLVED by the members of the Sangamon County Board this 9th day of November, 2021, in order to obtain the objections set forth above, that Title 15 of the Sangamon County Code shall be revised and amended as set forth in Exhibit A hereto, effective January 1, 2022.



15.05.060 Purpose

To further the purpose of promoting and safeguarding the public health, safety, comfort and welfare by regulating the buildings and other structures more specifically described in Section 15.01.020 of this chapter, it is necessary and desirable to adopt the regulations of national model codes promulgated by expert organizations long devoted to establishing technical requirements after thorough study and consideration of the public interest. The provisions of 55 ILCS 5/5-6002 of the State of Illinois authorize the County of Sangamon to adopt the technical codes and public records set out in Section 15.05.070 below without setting forth the provisions in full. Provided, however, that at least three copies of such codes and public records shall be kept on file in the office of the county clerk and there kept available for public use, inspection and examination.

Chapter 11. Delete in its entirety. The provisions of the Illinois Accessibility Code referenced in Section 15.05.070 shall be applicable in place of Chapter 11, and whenever reference is made to the accessibility provisions of this code, the reference shall be construed to be to the accessibility provisions of the Illinois Accessibility Code.

Chapter 29. Delete in its entirety. The provisions of the Illinois Plumbing Code referenced in Section 15.05.070 shall be applicable in place of Chapter 29, and whenever reference is made to the provisions of the International Plumbing Code in the plumbing provisions of this code, the reference shall be construed to be to the provisions of the Illinois Plumbing Code referenced in Section 15.05.070.

15.05.160 Department Of Building Safety

The Department of Building Safety is hereby created and the official in charge thereof shall be known as the building official. The Department of Building Safety shall be a subdepartment of the Department of Public Health Building and Zoning. The building official shall be designated by resolution of the Sangamon County Board which shall be deemed the chief appointing authority of Sangamon County. The duties and powers of the building official and the power to appoint assistants shall be provided in Sections 103 and 104 of Chapter 1 of the International Building Code, 2000 2018 Edition and Sections R103 and R104 of the International Residential Code, 2000 2018 Edition. The salary of the building official and any assistants shall be set by the Sangamon County Board.

15.05.170 Additional Powers And Duties Of Building Official

The building official appointed pursuant to Section 15.05.160 shall also administer the departments created and exercise the powers and duties conferred upon the code official by the following codes:

The building official shall also provide for the administration and enforcement of the Illinois Plumbing Code by requiring permits, inspection and fees all as provided in 225 ILCS 320/37, and provide for the inspections and administration required to enforce the Illinois Accessibility Code.

The Department of Property Maintenance Inspection is hereby created. The Department shall be a subdepartment of the Public Health Department of Sangamon County. The code official for the Department and for the administration of the International Property Maintenance Code as defined in Section 15.05.070 shall be the Director of Public Health of Sangamon County.

Article 15.05-IV Violations

15.05.210 Violation Penalties

Any person who violates a provision of the codes referenced in Section 15.05.070 or fails to comply with any of the requirements thereof, or who erects, constructs, alters or repairs a building or structure in violation of the approved construction documents or directive of the building official or code official, or of a permit or certificate issued under the provisions of the codes, commits a petty offense.

Any person who commences construction without having made application to the Department of Building Safety and received authorization from said department to begin said construction shall be subject to an application fee of one hundred fifty percent of the normal fee.

The state's attorney may bring action to enforce compliance of the requirements of this ordinance by filing an action before the Sangamon County Ordinance Violation Hearing Department or by filing an action in Sangamon County Circuit Court requiring conformance with this article, fines, fees and costs for violation of this article or such other order as the Court or hearing officer may deem necessary.

Any person who violates this article shall be fined not less than twenty-five dollars nor more than two thousand five hundred dollars. A separate offense shall be deemed committed upon each day during or on which a violation occurs or continues.

Article 15.05-V Board Of Appeals

15.05.220 Appeal

A Board of Appeals is hereby created which shall be constituted and shall function as provided in Appendix B of the International Building Code, 2000 Edition, as amended by Section 15.05.080. The Board of Appeals shall hear all appeals authorized by any of the codes defined in Section 15.05.070. The fee required for an application for appeal shall be two hundred dollars. No appeal shall be permitted unless the fee is paid to the building or code official at the time of the application for appeal.
