WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of Child Advocacy Center wishes to apply for and accept an a grant from Illinois Criminal Justice Information Authority for the Child Advocacy program in the amount of approximately \$233,203.00; and

WHEREAS, this grant will allow Child Advocacy Center to provide coordination for investigations into child abuse; and

WHEREAS, as documented by the approval of this resolution, the Finance Committee has approved the Child Advocacy Center Department's request to apply for the VOCA grant and the committee recommends that the County Board approve the acceptance of this grant, if awarded by Illinois Criminal Justice Information Authority.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 11th day of July, 2023, approves the acceptance of the VOCA grant, which is detailed above, if the grant is awarded to the County by Illinois Criminal Justice Information Authority. The County Administrator is authorized to sign required grant documents to execute the agreement for this grant.


