#### **Summary:**

Sangamon County corrections personnel orders supplies for the jail and inmates. Examples of these purchases are inmate kits (personal hygiene), toilet paper, paper towels, garbage bags, inmate clothing, cleaning supplies, etc. Orders are placed for supplies as needed. Some larger orders (e.g. mattresses) are also placed, but are limited because of storage and need.

Sangamon County will purchase from a number of alternate vendors. Any additional vendors requesting to be added to the list of vendors for price comparisons at the time of order will be added. Sangamon County will always consider both quality and price when making purchasing decisions and will work with all vendors to promote savings. Vendor purchases with any one vendor should not exceed \$50,000 per year. The only vendor exceeding \$30,000 in sales for FY18 was Bob Barker. Gilson's was the only vendor less than \$30,000, but more than \$3,500. A variety of other supply vendors including Charm-Tex, Triad Industrial, and Phoenix Supply are considered at the time of purchase. State of Illinois contract pricing and their vendors are also considered.

The PO amount is based on FY18 purchases from the vendors identified above and FY19 forecasts.
