WHEREAS, the Department of Court Services wishes to apply for and accept an a grant from U.S. Department of Justice-Bureau of Justice Assistance for the PREA Targeted Implementation Planning & Support Program program in the amount of approximately \$20,000 to \$200,000; and

WHEREAS, this grant will allow Court Services to provide PREA certification for the Juvenile Detention Center; and

WHEREAS, as documented by the approval of this resolution, Court Services Committee and the Finance Committee have approved the Court Services Department's request to apply for the U.S. Department of Justice-Bureau of Justice Assistance grant and the committees recommend that the County Board approve the acceptance of this grant, if awarded by U.S. Department of Justice-Bureau of Justice Assistance.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 13th day of August, 2019, approves the acceptance of the U.S. Department of Justice-Bureau of Justice Assistance grant, which is detailed above, if the grant is awarded to the County by U.S. Department of Justice-Bureau of Justice Assistance. The County Administrator is authorized to sign required grant documents to execute the agreement for this grant.
