## **Explanation of Expenditure**

The Public Defender's Office uses Forensic Psychiatrists to examine clients for fitness to stand trial and sanity evaluations. \$40,000 is quite a substantial amount of funds and the reason we are asking for such a substantial amount of money, is because we are seeking approval for the entire year. We have no way of knowing exactly how many cases will need Forensic Examinations, however last year (2018) we spent \$37, 800.00 with Dr. Pan. I have discussed legal review with Attorney Dwayne Gab and although we do not need formal quotes or bids, because this falls under professional services, he recommend, I do my due diligence and do a google search to ensure we are getting a fair price. I did so, and what I found was the going rate for a Forensic Psychiatrist is \$250.00 - \$900.00 per hour based on expertise. We majorly use Dr. Pan who charges \$300.00 per hour and is very time efficient, which helps keep the cases moving along and is a very fair price.

We hire Dr. Pan on each case individually and enter into an agreement/contract per case, which does not come close to or exceed \$30,000.00
