Sheriff's Office Resolution

WHEREAS, the Sheriff's Office has an Intergovernmental Agreement (IGA) currently in place for the housing of Federal Inmates.

WHEREAS, current Covid restrictions do not allow for Federal Inmates to be transported to Federal Court by US Marshals.

WHEREAS, Federal Inmates now participate in Federal Video Court at the Sangamon County Complex.

WHEREAS, Sangamon County Correctional Officers transport and guard the inmates during Federal Video Court.

WHEREAS, the US Department of Justice and the US Marshals Service have agreed to reimburse Sangamon County at a rate of \$21.15 per hour for this service.

WHEREAS, as documented by the approval of this resolution, the Jail Committee has approved the Sheriff's Office request to amend this IGA and recommends that the County Board approve of the same.

NOW THEREFORE BE IT RESOLVED BY THE MEMBERS OF THE SANGAMON COUNTY BOARD, in session this 12th day of January, 2021 A.D., that the Sheriff is authorized to modify the IGA with the US Department of Justice and the US Marshals Service.
