A RESOLUTION APPROVING AND AUTHORIZING SANGAMON COUNTY TO AMEND THE PROFESSIONAL SERVICES AGREEMENT WITH THE BOARD OF TRUSTEES OF SOUTHERN ILLINOIS UNIVERSITY, ON BEHALF OF ITS SCHOOL OF MEDICINE, FOR CONTACT TRACING SERVICES

WHEREAS, Section 10 of Article 7 of the 1970 Constitution of the State of Illinois and Section 3 of the Intergovernmental Cooperation Act (5 ILCS 220/3) provides that a public agency may enter into an intergovernmental agreement with other public agencies to obtain services; and

WHEREAS, under the provisions of the Intergovernmental Cooperation Act, 5 ILCS 200/1 et seq., governmental units of the State of Illinois are permitted to enter into Intergovernmental Cooperation Agreements for any lawful purpose; and

WHEREAS, the Southern Illinois University is a system of public universities, including the Southern Illinois University School of Medicine located in Springfield ("University"); and,

WHEREAS, on September 14, 2020, Sangamon County ("County") and the University entered an agreement for contact tracing services; and

WHEREAS, the University and County wish to amend the Agreement to strike out non-operational provisions that are not applicable to contact tracing services; and

WHEREAS, deleting the non-operational provisions does not otherwise impact the contract tracing services being provided by University;

WHEREAS, the County's Department of Public Health ("Department") and University desire to amend the Agreement to more appropriately state the Services;

AMENDMENT NO. 1 TO UNIVERSITY CONTRACT R-10509

THE BOARD OF TRUSTEES OF SOUTHERN ILLINOIS UNIVERSITY, ON BEHALF OF ITS SCHOOL OF MEDICINE AND COUNTY OF SANGAMON, ILLINOIS

PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT No. 1 TO UNIVERSITY CONTRACT NO. 10509 is made and entered into, by and between COUNTY OF SANGAMON, ILLINOIS for and on behalf of its Department of Public Health (hereinafter collectively referred to as the "Department") and THE BOARD OF TRUSTEES OF SOUTHERN ILLINOIS UNIVERSITY, a body politic and corporate of the State of Illinois, located at Carbondale, Illinois, for and on behalf of its School of Medicine (hereinafter collectively referred to as "University").

RECITALS:

WHEREAS, Department and University have heretofore entered into University Contract No. 10509, effective August 1, 2020, and hereinafter referred to as the ("Agreement"); and

WHEREAS, the Agreement provides for the University to furnish professional medical services, on an as needed basis, to provide testing, contact tracing, and Pandemic Health Worker services as they specifically relate to the COVID19 pandemic (Services"); and

WHEREAS, Department and University desire to amend the Agreement to appropriately state the Services.

NOW, THEREFORE, in consideration of the covenants, terms, conditions and provisions which are contained in this Agreement, the Parties agree as follows:

- 1. All references to testing shall be deleted.
- 2. This Amendment No. 1 is delivered to be effective as of August 1, 2020.
- 3. Except as hereinabove modified, the terms and conditions of the original Agreement and any subsequent amendments hereto shall remain in full force and effect.
