- 1 Transfer Center/Bus Stop Divernon \$100,000
- 1 Transfer Center/Bus Stop Illiopolis \$85,000
- 1 Magnetic Card Swipe Software & Hardware \$18,000

Overall Total - \$810,135


WHEREAS, there is no matching funds component to this Capital Grant
