WHEREAS, County policies and procedures require both the assigned oversight committee and the Finance Committee to approve all requests to apply for grants from Federal and State agencies, as well as grants from all other entities; and,

WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board; and,

WHEREAS, the Springfield-Sangamon County Regional Planning Commission wishes to apply for and accept a grant from the Illinois Department of Transportation in the amount of approximately \$250,000; and,

WHEREAS, this grant will allow the Springfield-Sangamon County Regional Planning Commission to retain a consultant to create a redevelopment land use plan for the 9th Street/Peoria Road to Veteran's Parkway corridor; and,

WHEREAS, as documented by the approval of this resolution, the Finance Committee has approved the Springfield-Sangamon County Regional Planning Commission's request to apply for the planning grant and the committee recommends that the County Board approve the acceptance of this grant, if awarded by the Illinois Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 10th day of March, 2020, approves the acceptance of the planning grant, which is detailed above, if the grant is awarded to the County by the Illinois Department of Transportation. The Executive Director of the Springfield-Sangamon County Regional Planning Commission is authorized to sign required grant documents to execute the agreement for this grant.
