

Resolution No. 221

WHEREAS, the County has identified the need to purchase seven (7) vehicles during the Fiscal Year beginning December 1, 2020; and

WHEREAS, one (1) vehicle will be purchased for each department of Public Health, OEM, Zoning and Fleet Maintenance and an additional three (3) Sheriff's Office vehicles; and

WHEREAS, the purchase of these vehicles and equipment will be from the vendors awarded the state purchasing contracts or from vendor quotes; and

WHEREAS, financing will be entered into a contract with INB, selected through the specifications of an RFP process at a fixed annual percentage rate of 0.959%, and

WHEREAS, the financing shall be a three year contractual agreement, with a deposit down in the amount of thirty four thousand two hundred fifty five dollars (\$34,255) from the Justice Assistance Grant, and

WHEREAS, for the seven (7) vehicles being financed, at a total of one hundred fifty thousand dollars (\$150,000); the County will pay regular annual principal payments and all accrued unpaid interest due as of each payment date, December 15, 2021, December 15, 2022, and December 15, 2023 respectively; and

NOW THEREFORE BE IT RESOLVED BY THE COUNTY BOARD MEMBERS OF SANGAMON COUNTY, in session this 11th day of May, 2021 A.D., that the above purchases at a total cost of one hundred eighty four thousand two hundred fifty five dollars (\$184,255) are accepted for the vehicles and for payment of said vehicles from Capital Expenditures appropriation and the Justice Assistance Grant.
