WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of Court Services wishes to apply for and accept an a grant from Illinois Criminal Justice Authority for the Family Violence Coordinating Council program in the amount of approximately \$37,269.00; and

WHEREAS, this grant will allow Court Services to provide a forum to improve the institutional, professional and community response to family violence; and

WHEREAS, as documented by the approval of this resolution, Court Services Committee and the Finance Committee have approved the Court Services Department's request to apply for the Family Violence Coordinating Council grant and the committees recommend that the County Board approve the acceptance of this grant, if awarded by Illinois Criminal Justice Authority.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 9 day of June, 2020, approves the acceptance of the Family Violence Coordinating Council grant, which is detailed above, if the grant is awarded to the County by Illinois Criminal Justice Authority.
The County Administrator is authorized to sign required grant documents to execute the agreement for this grant.


