WHEREAS, County policies and procedures require that the acceptance of grants of \$30,000 or more must be approved by the full County Board;

WHEREAS, the Department of Community Resources wishes to apply for and accept an a grant from DCEO for the LIHEAP Cares Act Grant program in the amount of approximately \$624,983; and

WHEREAS, this grant will allow Community Resources to provide Disaster relief from Coronavirus in the form of Utility Assistance to lower income residents of Sangamon C; and

WHEREAS, as documented by the approval of this resolution, Community Resources Committee and the Finance Committee have approved the Community Resources Department's request to apply for the LIHEAP Cares Act grant and the committees recommend that the County Board approve the acceptance of this grant, if awarded by DCEO.
