

Resolution # 31-1

WHEREAS, County policies and procedures require both the assigned oversight committee and the Finance Committee to approve all requests to apply for grants from Federal and State agencies, as well as grants from all other entities; and,

WHEREAS, County policies and procedures also require that the acceptance of grants of \$30,000 or more must be approved by the full County Board; and

WHEREAS, the Sangamon County Department of Public Health wishes to apply for and accept a grant from the Ounce of Prevention Fund through the Illinois Department of Human Services for the Healthy Families Illinois Grant in the amount of \$225,000.00; and

WHEREAS, this grant will allow Sangamon County Department of Public Health to provide intensive home-visitation services to new and expectant families with identified risk factors for child maltreatment and whose income is less than or equal to 200% of the Federal Poverty level. Grantee will recruit parents prenatally or within two weeks of birth and provide home visits lasting at least sixty minutes during which they will provide strength based comprehensive services that reduce the parents risk for child maltreatment by enhancing parenting skills, encouraging healthy growth and development and improving family functioning; and

WHEREAS, as documented by the approval of this resolution, Finance Committee has approved the request of the Sangamon County Department of Public Health to apply for the Healthy Families Illinois Grant from the Ounce of Prevention Fund through the Illinois Department of Human Services; and the Committee recommends that the County Board approve acceptance of this grant, if awarded by the Ounce of Prevention Fund.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 11th day of June, 2019, approves the acceptance of the Healthy Families Illinois Grant, which is detailed above, if the grant is awarded to the County by the Ounce of Prevention Fund. The County Administrator is authorized to sign required grant documents to execute the agreement of for this grant.
