WHEREAS, a Request for Proposal (RFP) was issued in July, 2019 and the evaluation committee selected ADANI Systems from four responding vendors, and

WHEREAS, the total cost of the unit will be \$184,750 which will include the cost of the unit, installation and a four (4) year warranty, and

WHEREAS, upon approval of this Resolution, a contract will be finalized between the Sheriff's Office and ADANI Systems with consultation from the State's Attorney's Office, and

WHEREAS, the purchase of the Full Body Security Scanner will be purchased using funds from the Inmate Welfare Fund,
