

WHEREAS, Sangamon County has determined the appropriateness of insuring its licensed vehicles against loss, and

WHEREAS, R.W. Troxell & Company, as part of its contract with Sangamon County, annually coordinates the renewal of the County's vehicle insurance to ensure that the appropriate coverage is obtained at a competitive rate, and

WHEREAS, in 2013 R.W. Troxell solicited quotes for the County's vehicle insurance and received only one response, which was from the Cincinnati Insurance Company who was awarded the County's 2013 insurance contract for vehicle coverage; and

WHEREAS, the Cincinnati Insurance Company has quoted a premium price of \$25,846 for the renewal of the County's vehicle insurance coverage for the year beginning April 20, 2014; and

WHEREAS, the quoted premium from the Cincinnati Insurance Company is \$2,472 more than the premium for the prior year, due largely to the purchase of new vehicles during 2013.

NOW, THEREFORE, BE IT RESOLVED that the Sangamon County Board, in session this 11th day of March 2014, approves the renewal of the County's vehicle insurance policy with the Cincinnati Insurance Company for the period April 20, 2014 through April 20, 2015 at the quoted premium price of \$25,846, and furthermore authorizes the County Auditor to sign any required policy renewal documents.
