

RECOMMENDATION OF THE BOARD OF APPEALS



- (i) Existing uses of property within the general area of the property in question.

**North – Residences, cell tower, railroad, and cropland. East – Residences, railroad, and cropland. South – Residences and pasture. West – Residences.**

- (ii) The zoning classification of property within the general area of the property in question.

**North, South, and West – Agricultural. East – Agricultural and R-1.**

- (iii) The suitability of the property in question to the uses permitted under the existing zoning classification.

**The LESA score of 146 indicates the property is acceptable for non-agricultural development.**

- (iv) The trend of development, within the vicinity since the property was originally classified.

**The area has a rural residential trend. In Zoning Case #2012-004, the subject property was granted a variance to allow the parcel to be less than 40 acres and the adjacent 1.6 acre parcel was split off from the subject property and granted R-1 zoning. In 2002, R-1 was granted for two parcels southeast of the subject property.**
