(i) Existing uses of property within the general area of the property in question.

To the north is a single family residence. To the east is a single family residence and cropland. To the south is pasture. To the west are single family residences.

(ii) The zoning classification of property within the general area of the property in question.

The property is surrounded by Agricultural zoning.

(iii) The suitability of the property in question to the uses permitted under the existing zoning classification.

The Land Evaluation and Site Assessment score of 146 indicates the property is acceptable for non-agricultural development.

(iv) The trend of development, within the vicinity since the property was originally classified.

The area has been relatively stable with some single family residential development. A parcel to the southeast was rezoned to R-1 in 2002 and another parcel to the southeast was rezoned to R-1 in 2005.

The Zoning Board of Appeals shall not recommend to the Sangamon County Board that the regulations of this ordinance be varied as authorized in F. (1) hereof, unless it shall make findings of fact based upon the evidence presented to it in each specified case:

(i) that the property in question cannot be economically used or yield a reasonable return, if permitted to be used only for the conditions allowed by the regulations.

The request is made to facilitate division of the property to allow for construction of a single family residence.

(ii) that the plight of the owner is due to circumstances unique to the property and not generally applicable to other property in the area.

The petitioner would like to divide the property in order to construct a single family residence. Given the size of the property, the variance is only needed for proposed Lot 1 that already contains a single family residence and outbuildings.

(iii) that the variation, if granted, will not alter the essential character of the locality, impair an adequate supply of light and air to adjacent property, increase the congestion of traffic, or diminish or impair property values in the locality.

No negative impact is anticipated.
