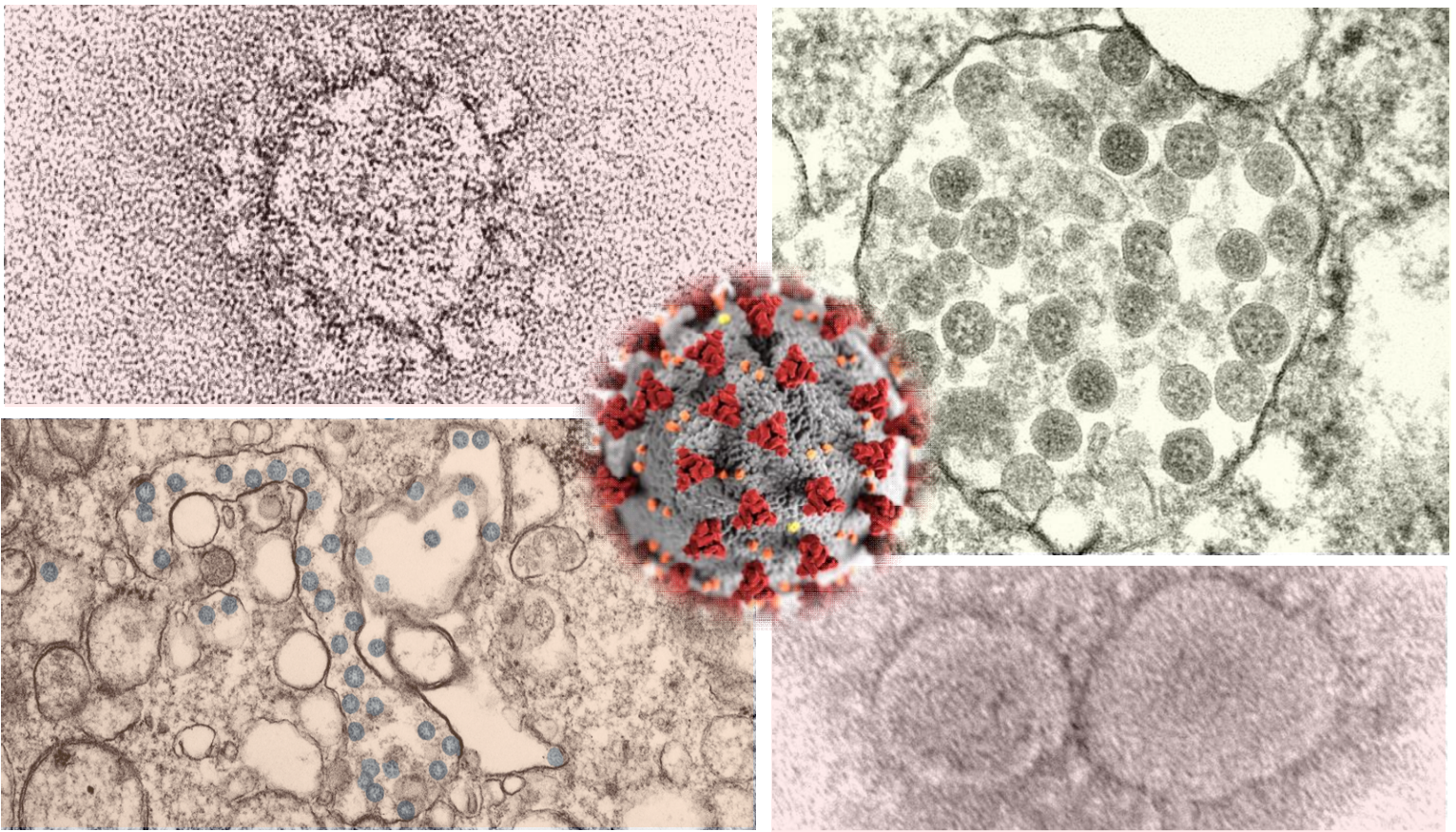

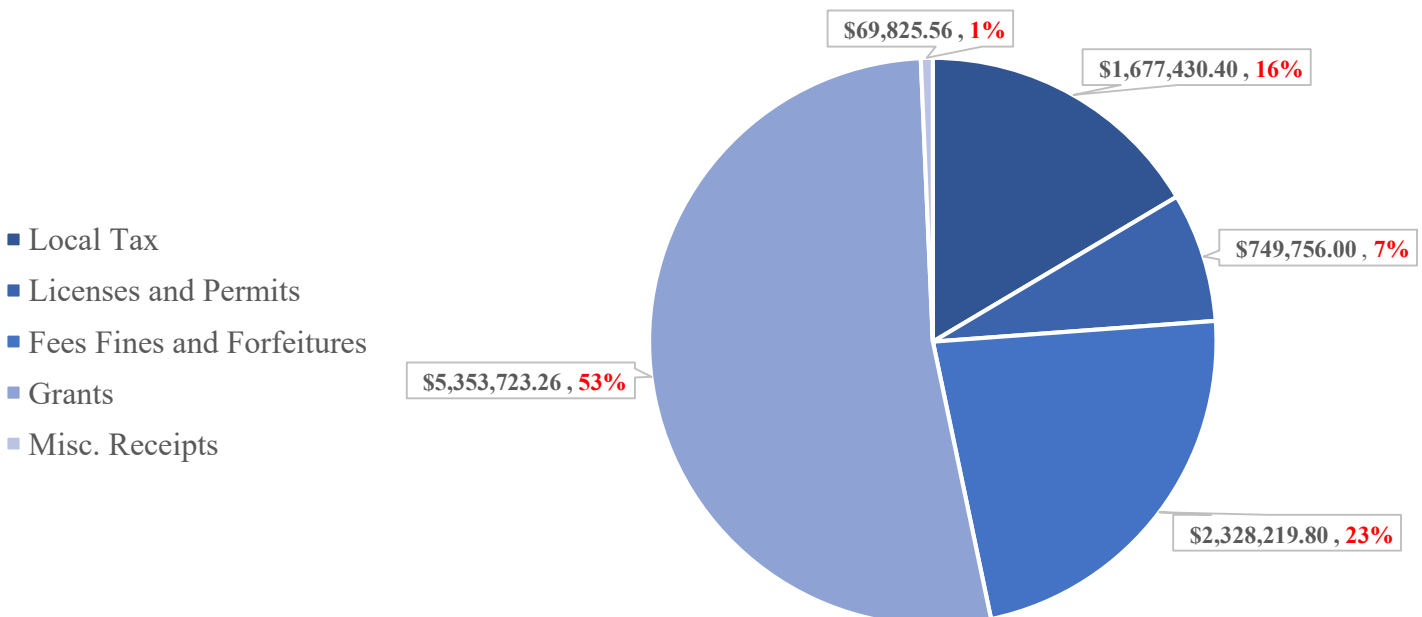

In Sangamon County, the first COVID-19 case was documented on March 17th, 2020. By the end of 2020, Sangamon County would have 13,219 confirmed or probable cases of COVID-19 and 176 deaths due to the virus. During this year, the health department developed and implemented various operational efforts to help community members during this pandemic. 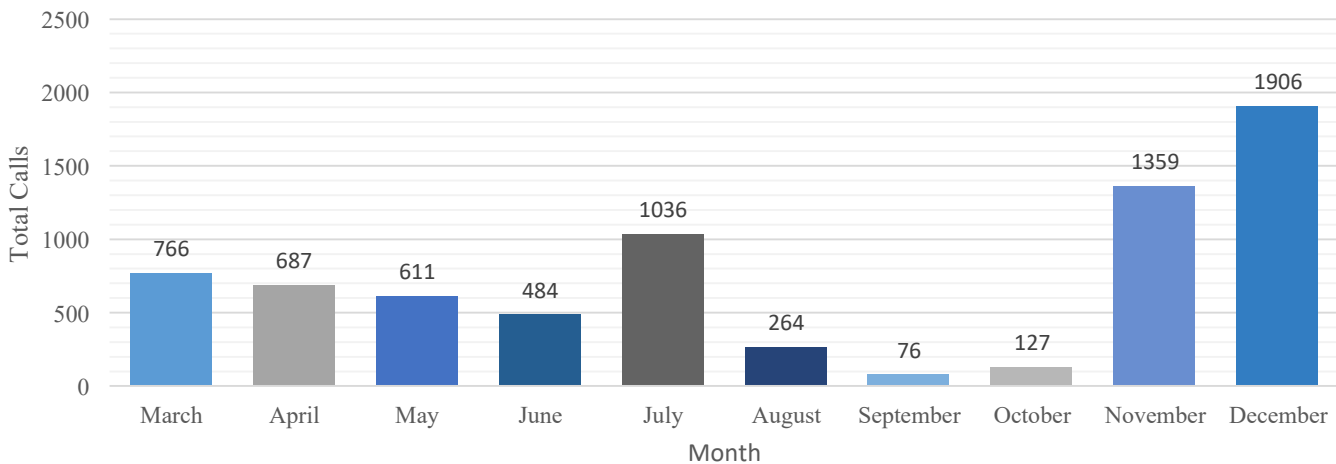
- Hotline dedicated to COVID-19

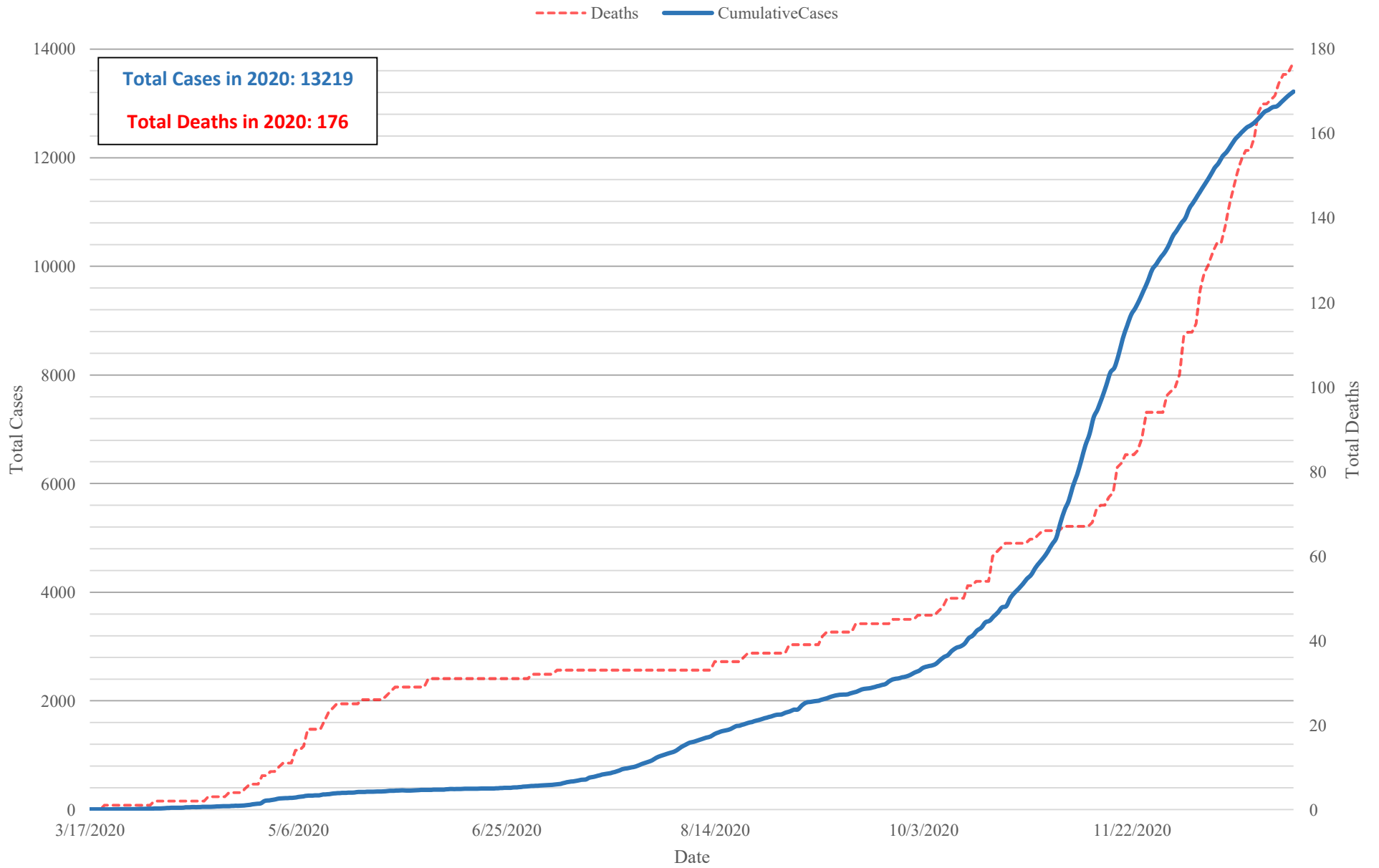

Sangamon County Cumulative Cases/Deaths (March 2020 to December 2020)

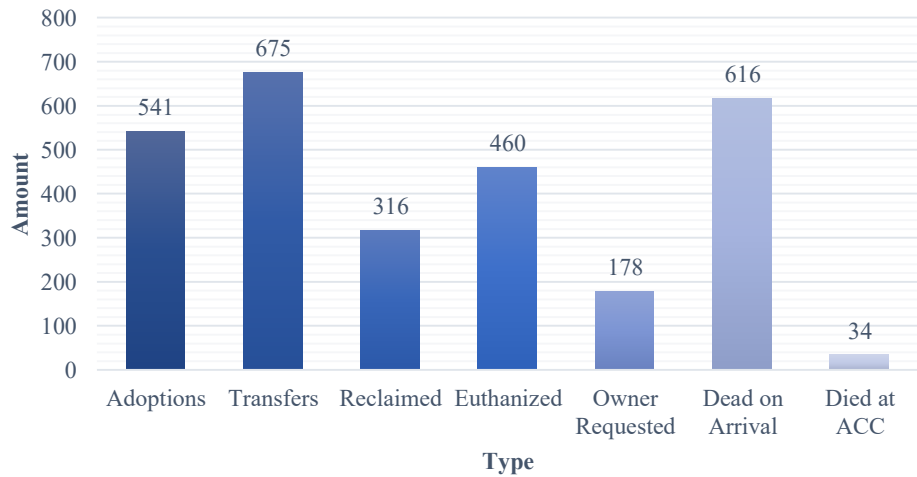


Sangamon County Animal Control & Adoption Center

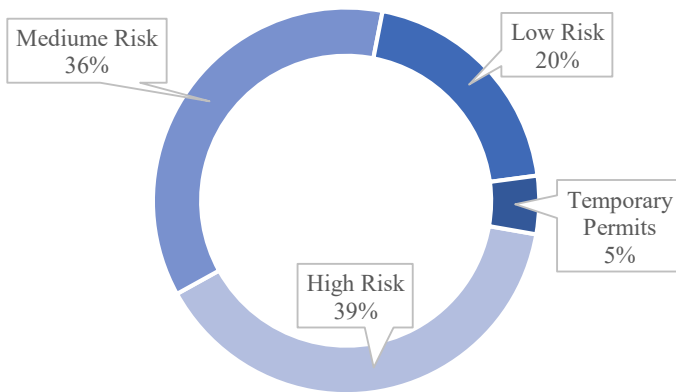

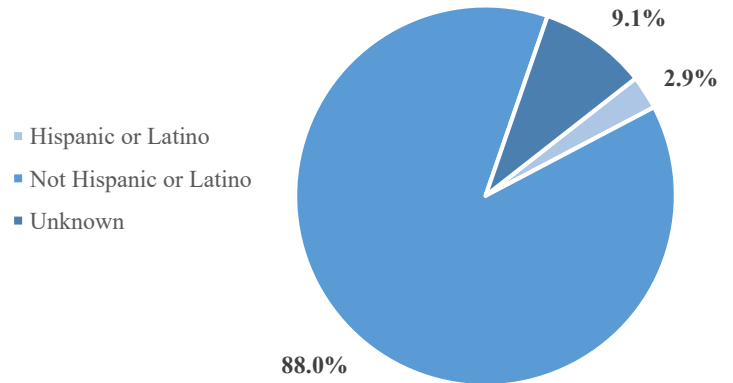

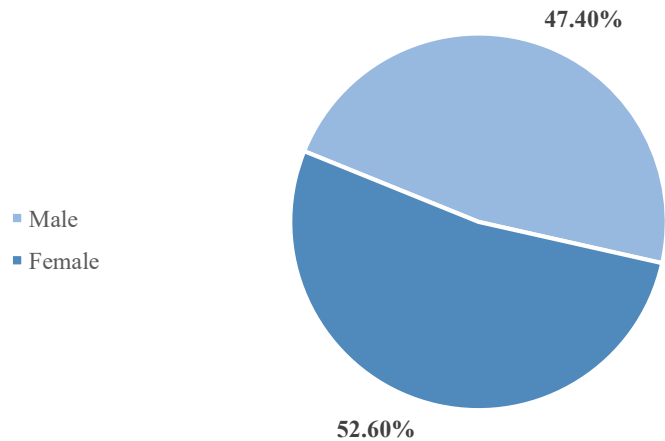

About Sangamon County Department of Public Health

Sangamon County is the 10th largest Health Department in Illinois with an annual budget exceeding \$10 million which serves a population of over 200,000. Sangamon County is home to the Capitol, State Fair, Abraham Lincoln sites and the 183rd Air National Guard Unit. We serve 26 townships and work with a variety of populations and organizations. Through community-oriented engagement and collaboration, we continually strive to promote and provide public health services to all community members within Sangamon County.

About this Annual Report

The Sangamon County Department of Public Health prepares an annual report to provide better transparency to our community and to abide to the regulatory requirements set forth to measure the services we offer.
